## **2014 : Second Session**

### **Part one**

#### **Activities of the PACE (Parliamentary Assembly of the Council of Europe)**

*The second 2014 session of the Council of Europe took place from 7th to 11<sup>th</sup> of April in Strasbourg, France.*

*Due to the situation in Ukraine, the Parliamentary Assembly of the Council of Europe (PACE) decided to remove the Russian delegation's voting rights but not to annul their credentials.*

*Mr Kurz, Austrian President of the Committee of Ministers, and Mr Fischer President of Austria, addressed the Assembly. The PACE decided to grant partner for democracy status to the Kyrgyz Parliament and listened to the annual activity report by the Commissioner for Human Rights M. Nils Muiznieks. Other highlights included a report on prostitution, trafficking and modern slavery in Europe, a debate on user protection and security in cyberspace as well as the right to internet access, the protection of minors against excesses of sects, and ending child poverty in Europe.*

#### ***“A threat to the human rights of minority religious groups”***

*MEP Ghiletschi stressed the danger of this report as there is no definition of the word sect, this report could be used against children and parents belonging to minority religious groups.*

## **Part Three**

### **COING (Conference of international NGO) Activities**

*This session was not officially a COING meeting although several working groups took place*

***A Working Group on "Combating Hate Speech" was set up to offer a contribution from representatives of civil society to the development of a General Policy Recommendation on Combating Hate Speech to be put to the governments of the Council of Europe, to develop the concept of a White Paper on Combating Hate Speech, to serve as a guide to thinking and action for the use of INGOs, media and political parties.***

***This White Paper should be presented at a Forum of Civil Society, in 2016, in collaboration with the Council of Europe, ECRI, media and social networks and political parties.***

***65 representatives of INGOs have signed up. WUCWO Representative is not a member of this group but will watch the development of the work. Hate Speech doesn't have an agreed definition and is ambiguous. This new wording is actually another threat to freedom of expression, conscience and religion.***
